PUNJAB ORDINANCE No. IX OF 1983.

AN

ORDINANCE

to amend the laws relating to certain Universities in the Punjab.

WHEREAS, it is expedient to amend the laws relating to certain Universities in the Punjab for the purposes hereinafter appearing;

Preamble.

NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 read with the Laws (Continuance in Force) Order, 1977 (CMLA Order No. 1 of 1977) and the Provisional Constitution Order, 1981 (CMLA Order No. 1 of 1981), the Governor of the Punjab is pleased to make and promulgate the following Ordinance:—

1. (1) This Ordinance may be called the Universities Laws (Amendment) Ordinance, 1983.

Short title and commencement.

(2) It shall come into force at once.

2. The laws specified in the Schedule shall be amended in the manner specified in the fourth column thereof.
